I. PRICE CALCULATION

- 1.3 The Provider reserves the right to propose a discount on the prices specified in the Price List in the form of written notice sent to the Customer's contact e-mail or address. The specific conditions of the discount, especially its amount and period of validity, shall always be specified in the above notification. If the Customer accepts such a proposal, the price change agreement shall take precedence over the general modification of the conditions in the Price List. The Customer accepts the proposal, among other things, by charging the Electric Vehicle after receiving the Provider's notification, without explicitly rejecting the Provider's proposal beforehand.
